No late registration fees for the kids run.

CONDITIONS FOR THE PARTICIPANTS

Kids run

This is not a competitive race. The results are generated after finish. There is no doctor's certificate necessary.

Main course

All Italian participants are required to be in possession of a medical certificate according to the law D.M. from February 18, 1982. This certificate must be issued by an authorized sports physician and must be sent within July 7, 2019, only then the participant will appear on the starting list. If you do not send, mail or upload a medical certificate according to the regulations within July 7, 2019, you will automatically be listed in the category Just for Fun.

Attention!

Medical certificates with the label: run, marathon, football, etc. will not be accepted. We only accept those with the label: athletics. All foreign participants, who compete in the main run, are required to show a medical certificate of their general practitioner.

Just for Fun run, Nordic Walking, Handbiker, Bambini Apfellauf (kids run)

These runs are not competitive and so, there is no medical certificate necessary. The organiser does not accept any improper transactions. He does not process them and the participants do not have the right of a refund of their entry fee.

COURSE

Course description:

Gorgeous panorama! A more beautiful place for a running event can hardly be found. Athletes will almost entirely run on the cycling path along the lake, which is closed to traffic at the time of the competition. The start takes place in Graun near the historical steeple in the water at a sea level of 1,450 m. The first section is plain and runs about 5 km towards St. Valentin. At the end of the artificial lake, just before St. Valentin, participants cross the dam. Then follows a little hilly and partially shaded section direction valley station of the ski resort Schöneben until kilometre 11. The next part towards Reschen is plain again. If time, you can enjoy over and over again the stunning view to the highest mountain of South Tyrol, the Ortler (3,905 m). The last kilometres are plain and run partially on a gravelled surface.

15,3 km (approx. 80% asphalted – approx. 20% gravelled surface)

Every participant can freely choose the starting group according to his personal performance level.

TIMEKEEPING

Timekeeping is carried out by the company TDS Data Service with a time chip. The chip is integrated in the bib number. Participants are not allowed to take it down before and during the race. The bib number is personal and so, you are not allowed to exchange it.

MODIFICATIONS

Modifications and cancellation of the race

The organiser reserves the right to modify this regulation at any moment for the purpose of improving the organisation of the event. Possible changes regarding service, place and time information will be communicated to the participants in an appropriated way either through the confirmation of registration or on the website www.reschenseelauf.it. The homepage is the official information portal, on which all official information will be published. Should the race be cancelled due to an act of nature, the athletes do not have the right of a refund of their entry fee.

DECLARATION OF RESPONSIBILITY

Through the registration for the 20th Reschenseelauf the participant declares to agree and accept the regulations published on the website www.reschenseelauf.it. Additionally, the participant explicitly declares, on his own responsibility, to say the truth (art. 2 legge 04/01/1968 n° 15 come modificato dall'art. 3 comma 10 legge 15/05/1997 n° 127) and to relieve the organiser from any civil and criminal responsibility for damages on people and properties caused by himself.

LIABILITY

Exclusion of liability

With registration every participant declares the following:

In case of my participation at the Reschenseelauf I accept the exclusion of liability of the organiser for damages of every kind. I will neither assert claims against the organiser, the sponsors of the race, the near communities, the owner of private paths, nor against their representatives because of damages and injuries that could be caused through my participation at the event. I declare that I have exercised enough for the participation on this competition and that I am physically healthy. I have a personal liability insurance.

I agree that my personal data named at the registration, the photos, videos and interviews on the radio, television, advertising or books produced by myself, can be used for my part without any claim of remuneration. I ensure that my year of birth is correct and that my bib number will not be handed over to another person. I am aware of the fact that I will be disqualified if I change the official bib number in some way, especially if I hide the advertising print or make it unrecognisable or if I am accompanied by another person on bike during the run or similar. In case of a cancellation of the Reschenseelauf due to an act of nature (flood, storm, etc.), the entry fee will not be refunded.

PRIVACY REGULATION

Privacy regulation

Clarification writing according to art. 13. of the g.v.D. nr. 196 from 30.06.2003 regarding the protection of personal data when data processing

In terms of article 13 of the legislative decree nr. 196 from June 30, 2003 we INFORM you about the fact that we process personal data of customers and suppliers, as well as data of people, who deliberately pass on their personal data to our sales office or the management (by phone, fax or e-mail), as well as from people, whose data will be applied through third parties, for example, when gathering external data for commercial information, public lists etc., whereas in the latter case, it concerns exclusively personal data of common / usual kind and nature.

The association guarantees, within the context of legal guidelines, that the processing of the personal data will occur under the consideration of the fundamental rights and liberties, as well as the dignity of the affected people with special reference to the observance of secrecy, the personal identity and the right of protection of personal data.

Objectives and purpose of data processing:

- fulfilment of legal duties, regulations, community rules, as well as civil and fiscal laws

- fulfilment of possible contractual obligations towards the affected person

- fulfilment of activities connected with business operations of our company, such as filling out of internal statistics, accounting, guidance of the customers/suppliers accounting, objectives of commercial nature, like consignment of business information and advertising material for one's own purpose and for partner events (by post, fax and e-mail), marketing and market researches

- protection of claims and administration of liabilities

- objectives regarding insurance, especially credit insurance

With regard to the objectives listed above, the personal data will be forwarded if required:

- to public administration and authorities, if provided by law

- to credit institutions with which our company maintains business relations for the administration of claims/obligations and financing arrangements

- to all natural and/or legal, public and/or private people (legal-, administrative- and tax consultancy offices, courts, chambers of commerce, etc.), if the forwarding approves to be necessary or expedient for the pursuit of our activity, as well as to the above mentioned manner with the respective objectives

- Personal data which has been processed by our company are not subject to any diffusion.

Data processing can happen with or without the support of electronic, automatic means and includes all required processes, which are designated in Art. 4., Par. 1, letter a of the law representing decree nr .196 of June 30, 2003 and the processes that are essential for data processing. In any case, the data processing will be conducted under observance of all security measures that guarantee their security and confidentiality.

The data privacy act grants the affected people the possibility to exercise specific rights according to Art. 7. In detail he has the right to know what personal data the holder

owns about him and to receive information about whether there is some data available about him, even if they have not been saved and to provide him in a comprehensible form further details about these data, the origin and the reason and purpose for their processing. Furthermore, he has the right to learn more about the holder and the people responsible for the processing and about people and categories of people to whom these data will possibly be transmitted.

The affected person has the right to confirm, check, correct and add information to his data. Additionally, he has the right to apply for the data to be deleted, blocked and converted into anonymous data if the processing infringes the provisions of the law. He has the right to oppose the processing of his data for justified reason totally or partly, as well as demanding for cancellation, blocking or conversion into anonymous data. Furthermore, he can oppose the processing of his data without justified reason, if the data are used for commercial information, the dispatch of advertising material, direct sales and market and opinion research.

The representational rights can be asserted on the part of the person concerned or on the part of a person he has asked to, by means of a request directed to the designated person in charge via registered letter or email (info@reschenseelauf.it).

COOKIES

In order to facilitate the navigation on our portal, cookies will be saved. Cookies are text and information files, which the web-browser saves on your computer when you open a website. They do not make a connection to your person. We use them to save your browser language, so that you will directly be guided to the correct side when re-entering. If you do not wish so, you can deactivate the acceptance of cookies in your browser. The most browsers accept cookies automatically; however, they offer the possibility to refuse cookies or to show a warning before saving.

CONSERVATION OF NATURE

It is forbidden to throw away rubbish of any kind outside the marked service areas. The abandoning of the race track is not allowed due to reasons of nature protection. Should these rules be disregarded, you will be disqualified.

The track of the Reschenseelauf runs along the wonderful nature. The event is also a Going Green Event.

This is why it is very important to the organiser to respect the conversation of nature and environment. Necessary measures, like sufficient waste disposal points, will facilitate the observance of these rules.

BIB NUMBER DISTRIBUTION

Late registrations/bib number distribution

Late registrations will be charged with a fee of 50.00€. They are only possible on Friday, 12 July 2019 from 3 p.m. to 7 p.m. or on Saturday, 13 July 2019 from 10 a.m. to 8 p.m. at

the bib number distribution in the start and finish area. Participants of the Bambini-Apfellauf (kids run) do not have to pay extra for late registrations.

LATE REGISTRATIONS

Late registrations will be charged with a fee of 50.00 €. They are only possible on Friday, 12 July 2019 from 3 p.m. to 7 p.m. or on Saturday, 13 July 2019 from 10 a.m. to 2.15 p.m. at the bib number distribution in the start and finish area. The participants of the Bambini-Apfellauf (kids run) do not have to pay extra for late registrations. Late registrations for kids are only possible on Friday, 12 July from 3 p.m. to 7 p.m. or on Saturday, 13 July from 10 a.m. to 16.00.

REFUND OF PARTICIPATION FEE

Paid registration fees are normally NOT refunded. In case of illness, participants have the possibility to send a doctor's certificate to the organizer, which will then credit the already paid fee for the upcoming year.
